Note: The BEC serves as a means for converting retained import data into end use categories that are meaningful within the framework of the System of National Accounts; intermediate goods and consumption goods. Except categories 321* and 51* which are used extensively namely capital goods, both for industry and for household consumption and category 7* which includes a range of commodities, the correspondence of the 16 remaining BEC basic categories with the basic classes of goods in the SNA are:

1 Capital Goods: sum of categories 41* and 521*

2 Intermediate Goods: sum of categories 111*, 121*, 21*, 22*, 31*, 322*, 42* and 53*

3 Consumption Goods: sum of categories 112*, 122*, 522*, 61*, 62* and 63*

* The asterisk follows each reference to a BEC classification as a device to avoid confusion with the numbered sections, divisions and groups of the standard international trade classification, revision 4.
