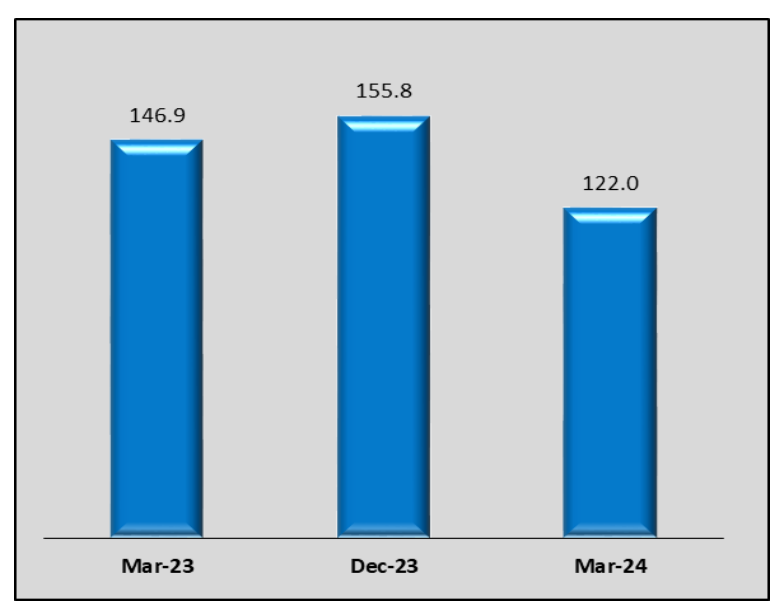

CONSTRUCTION STATISTICS

March Quarter 2024

The findings presented in this release is based on data gathered from all registered Private Building and Civil Works Contractors engaged in work for both the Private Sector and the General Government. It provides a short-term indicator of the sectors performance.

GRAPH 1: TOTAL VALUE OF WORK [FJD-MILLIONS]

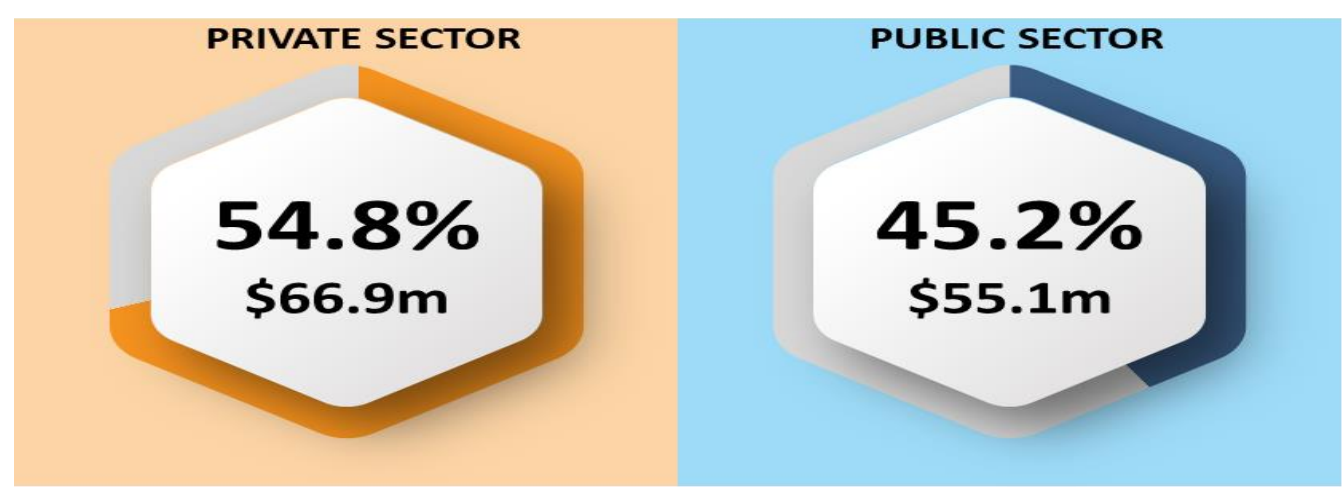


Key Facts

- Total estimated value of work put-in-place was \$122.0 million for the March quarter of 2024.
- Total value of work put-in-place decreased by 21.7 percent (\$33.8 million) when compared to the December quarter of 2023.
- Total value of work put-in-place also decreased by 16.9 percent (\$24.9 million) when compared to the March quarter of 2023.

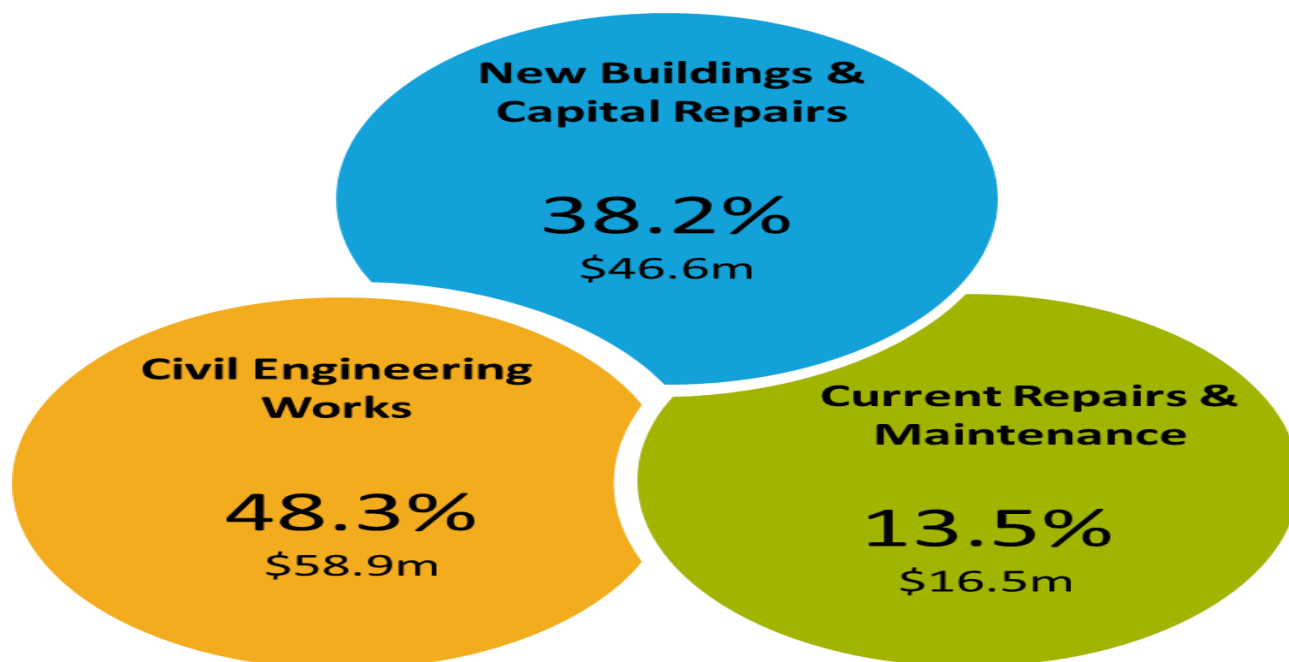
The breakdown of the \$122.0 million value of work done by Private and Public Sectors:
