


FIJI'S NOMINAL GROSS DOMESTIC PRODUCT (GDP) 2023 INCOME APPROACH

Income is generated for different institutional units in the economy during the production process. For instance, through the sale of materials for use as inputs by other establishments, receipts by owners for the use of their capital and the net tax receipts by government. Hence GDP can also be calculated as a sum of Compensation of Employees (COE), Gross Operating Surplus/Mixed Income (GOS/MI) and Net taxes on Production and Imports.

The 2023 estimate of \$12.2 billion is made up of the following components:


Figure 1: Gross Operating Surplus/Mixed Income






Gross Operating Surplus/ Mixed Income contributes 49.0 percent to total nominal GDP. It increased by 8.5 percent (\$0.5 billion) in 2023 when compared to 2022.


Figure 2: Compensation of Employees






Compensation of Employees contributes 30.9 percent to total nominal GDP. It increased by 12.3 percent (\$0.4 billion) in 2023 when compared to 2022.


Figure 3: Net Taxes on Production and Imports






Net Taxes on Production contributes and **Imports** 20.1 percent to total nominal GDP. It increased 20.6 percent (\$0.4 billion) 2023 when in compared to 2022.

The top 5 industries in terms of contribution to total compensation of employees are Education (13.8%), Public Administration & Defence (13.6%), Wholesale & Retail (12.3%), Transport & Storage (11.9%) and Manufacturing (8.2%).

Figure 5: Gross Operating Surplus/Mixed Income Contribution



The top 5 industries in terms of contribution to total gross operating surplus/mixed income are Agriculture (17.7%), Manufacturing (13.6%), Financial & Insurance (11.8%), Wholesale & Retail (11.6%), and Information & Communication (7.1%).
